

ROUNDTOWN UFO SOCIETY MONTHLY MEETING UPDATE MAY 2013

THE MUFON RADIO SHOW IS NOW BEING BROADCAST ON THE INTERNET VIA KGRARADIO.COM. IT IS ON THE FIRST FRIDAY OF EACH MONTH AT 9P.M. EST. IT IS A 2 HOUR BROADCAST.

INTERNATIONAL MUFON DIRECTOR DAVID MACDONALD IS GIVING A UFO PRESENTATION THIS MONTH AT THE SMITHSONIAN INSTITUTION'S ATOMIC TESTING MUSEUM IN LAS VEGAS. MUFON ALSO HAS AN EXHIBIT WITHIN THE MUSEUM. DAVID STATES MUFON IS NOW BEING SOUGHT AFTER, CONSULTED WITH, RECOGNIZED AND RESPECTED LIKE NEVER BEFORE.

HISTORIAN MICHAEL SCHRATT WAS GRANTED PERMISSION BY MUFON TO GAIN ACCESS TO LEONARD STRINGFIELD'S PERSONAL RESEARCH IN THE UFO CRASH/RETRIEVALS OF CRASHED SAUCERS AND BODIES BEING RECOVERED BY ELEMENTS OF THE UNITED STATES GOVERNMENT. PER STRINGFIELD'S ORIGINAL REQUEST, THE IDENTITIES OF PERSONNEL DIRECTLY INVOLVED IN THESE OPERATIONS WILL NOT BE DIVULGED. LEN'S RECORDS WERE COMPRISED OF 65 SMALL, THREE-RING BINDERS. (LEN WAS A PERSONAL FRIEND OF RUFOS DIRECTOR PETE HARTINGER). LEN PASSED AWAY IN 1994.

STANTON FRIEDMAN REPORTS ONE OF THE IMPORTANT UFO CASES WAS OF THE 1957 RB47 CREW OBSERVING A STRANGE CRAFT FLY AROUND THEIR AIRCRAFT VISUALLY AND PICKED UP BY THEIR RADAR FOR OVER AN HOUR. IT WAS ALSO OBSERVED BY GROUND RADAR AND EMITTED ELECTROMAGNETIC SIGNALS.

ROBERT HASTINGS REPORTS THERE HAS BEEN UFO ACTIVITY AT THE HANFORD PLUTONIUM PLANT NEAR RICHLAND, WASHINGTON. THE HANFORD SITE REPRESENTS TWO-THIRDS OF THE NATION'S HIGH LEVEL RADIOACTIVE WASTE BY VOLUME. IT IS THE MOST CONTAMINATED NUCLEAR SITE IN THE UNITED STATES. UFO SIGHTINGS CONTINUE TO OCCUR NEAR THE AREA.

THE CITIZEN HEARING ON DISCLOSURE WAS HELD APRIL 29 TO MAY 3 AT WASHINGTON D.C. THEIR MOTTO WAS "IF THE CONGRESS WON'T DO ITS JOB, THE PEOPLE WILL." SOME 40 RESEARCHERS AND MILITARY/AGENCY WITNESSES TESTIFIED. THE DISCLOSURE WILL BE FILMED FOR A DOCUMENTARY TITLED "TRUTH EMBARGO" BY JUST CAUSE ENTERTAINMENT".

AT THE CITIZEN HEARING ON DISCLOSURE RETIRED SERGEANTS JOHN BURROUGHS AND JAMES PENNISTON ANNOUNCED THEIR INITIATIVES TO FILE

FEDERAL LAWSUITS AGAINST THE VA FOR MEDICAL BENEFITS FOR INURIES THEY SUFFERED AT BENTWATERS RAF BASE IN DECEMBER OF 1980 WHILE THEY OBSERVED A UFO AT VERY CLOSE RANGE.
