The "gutted" 2023 NDAA UAPDB language:

Douglas Dean Johnson's article explains the modifications to the original 2023 NDAA UAPDB language very well. The wording which remains is pretty bleak compared to the original form. Nearly all enforceable leverage points included in the original language have been removed. Numerous additional articles have explained the key points. The most concerning discussion I've personally heard/seen on the topic may be Grant Cameron's discussion with Dave Scott of Spaced Out Radio stating his suspicion that the language changes now in effect MAY have been crafted to legalize or legitimize past criminal actions and nothing can be compelled to come forward now regarding anything held by governmental or quasi-governmental agencies. And I have no idea whether this is really true.....yet.
